2010 was a year of change and diversity for the ORA New Zealand Board and management team. Early in the year we began the process of re-establishing links with the worldwide ORA body, reconsidering our values and realigning ourselves with the ORA International Network. All in all, the ORA New Zealand team achieved many things in 2010.

We undertook to present ORA New Zealand in a more professional manner through updated publications, a new website, Facebook and YouTube. During 2010 we trialled new fundraising and promotional methods, including a gig, a movie night and a calendar. As a result more vulnerable children are now supported through sponsorship and a second Residential Care Home, playground and sick bay were constructed in Uganda.

Confirming our stance as an organisation that sends people as well as funds, a few Kiwi short-termers visited ORA project countries in 2010. ORA Uganda hosted Sam and Kim Trenwith and family for a five month stint, Catie and Sam Wilkinson and Pip Moffitt for ten days in October, and Chris and Jan Barker for three weeks in September. Another Sam (Hunt) with his wife Pauline spent three months in Bulgaria.

In November we moved to a new office in the Business Edge premises in King Street, Frankton, Hamilton, where we receive wonderful support from other businesses and personnel. A very positive move!

As an organisation, ORA New Zealand is going from strength to strength as God presents us with opportunities to partner with Him.



Financial review

Sources of income




In 2010 the main project supported by ORA New Zealand was in Uganda, with less than 1% of project funding sent to Pakistan flood relief and ORA's Haiti partner.

The Administration and Promotional expenditure percentage dropped from 36% in 2009 to 16% in 2010.

When considering funds raised specifically for Administration through the ORA Garage Sale in 2009 and other activities in 2010 this percentage dropped from 14% in 2009 to 10% in 2010.

Child sponsorship and private donations remain the major income for ORA New Zealand project support.

The above information has been extracted and summarised from the 2010 ORA New Zealand Financial Report for the year ended December 31st 2010.

Total income for 2010 was \$5,460 lower than the previous year; donations increased however the discontinuation of the Garage Sale realised lowered Designated Administration Income.

The cost of developing a new website increased promotional expenditure in 2010; however the rationalisation of the running of ORA New Zealand during the latter half of 2009 greatly decreased the administration and promotional overheads in 2010 to 16% of expenditure.
